Empty containers retain product residue, so obey hazard warnings and handle empty containers as if they were full.

For safe storage, store between 0 °C (32°F) and -18 °C (0.4 °F) Refrigerated storage is recommended to maintain product quality. Keep container tightly closed and in a cool, well-ventilated place away from incompatible materials.
